


# **THE ORIGIN OF UbitEx IN 2021**




# **2021 FLYING LEOPARD**

# ECOLOGICAL 05: CRYPTOCURRENCY PAYMENT



- A key role of cryptocurrencies is to allow both sides to make decentralized and trust-free money transfers. With the development of blockchain, more and more innovative payment methods are being created and tested.
- While decentralized payments can be made through cryptocurrency or USDT transfers, they can still be done better —
   for cheaper, faster transactions, scheduled transfers, conditional transfers, standardized invoice formats, and more.
- UbitEx Are studying changing the way we process payments by reset payments to flow patterns rather than familiar transactions. The possibility of new payments will generate a lot of potential currency applications. The new payment can be imagined as a "payasyouuse" with more refinement and higher accuracy (a model of payment by actual use).
- In UbitEx's new cryptocurrency payment method, UB token will be used as an important payment token and fee deduction token, that is, cryptocurrency payment through UbitEx, and UB will be used as a transit token for other cryptocurrencies and legal tender currencies. At the same time, the UB will be burned as a handling fee during the payment process. Therefore, UB has strong conversion properties and destruction properties.


# What is UB?





# **Example**Iedge BTC worth 5000 USDT and UB worth 5000 USDT Suppose the current price of UB is 1 USDT / piece



Assuming that the BTC rises by 10% after the expiration, the UB price remains unchanged



- Platform currency application scenarios and incentive models are enriched again.


